Project(250 words or less)*

Basin United has been one of the largest youth sport programs in the Klamath Basin for 20 years. The 60,000 square foot Mike's Field House is one of the largest multipurpose facilities not just in Southern Oregon, but in the Western United States. It is one of the Klamath Basin's premier amenities.

Basin United Soccer Club plans to leverage its facilities by becoming more active in the regional soccer community. Basin United Soccer Club will begin the strategic planning process for hosting soccer tournaments that will draw families to the Klamath Basin, thereby boosting tourism, lodging and restaurant business in the local economy. As a soccer club, our teams attend yearly soccer tournaments hosted by the Rogue Valley Soccer Club and the Redding Soccer Club. We have consistently observed these successful annual tournaments and the ways in which they significantly boost their local economies. The Rogue Memorial Challenge, for example, draws some 3,500 people from across the West for a weekend of events. Medford hotels sell out with bus-loads of tournament players.

The board would like to develop a plan to start hosting tournaments that would bring more visitors to the Klamath Basin and improve the local economy.

Please describe your project and how you will utilize the grant funding

Need of Funds(250 words or less)*

Basin United has expanded our efforts to provide opportunities for young and old in the Klamath Basin. Dedicated to both youth and adult soccer, we have in recent years become more engaged in Klamath's broader sports community by providing a location for competitive volleyball teams and elderly walkers. We have also recently begun work on a plan to develop an indoor basketball community, as well as using the courts for pickle ball. Basin United proudly hosts the Klamath Freedom Celebration and their "Movies in the Park" program to benefit local veterans and many other deserving charities. These outdoor activities and the opportunities they provide for Klamath residents to stay connected and healthy during this pandemic have never been more important. These programs only add to Klamath's resiliency, particularly for our vulnerable. Maintaining these important programs and the staff required to service them is critically important.

But Basin United believes that this is also the time to begin planning for a regional soccer tournament for spring 2021. We would use the Klamath County COVID-19 Emergency Response Grant to develop such a strategic plan. These funds would also help with the startup costs associated with the tournament, including signage, tournament guides, gear sales, field lining, tents, tables and chairs, and staff.

Basin United wants these tournaments to become a hallmark of Klamath Falls tourism. We will be working tirelessly to ensure that there is annual growth occurring with these tournaments. While our initial target is to attract residents from Southern Oregon and Northern California, our ambition is to stretch our reach into other markets. With consistent event success there will be multiple ways in which we can increase revenue that can be reinvested into making the event more and more attractive, simultaneously introducing more revenue opportunities for Klamath County Tourism.

What are the long term implications of receiving grant funds.

Short term success in this industry is defined by planning and executing an event from start to finish, with the end result having at least broke even financially. If our community partners, sponsors and soccer families walk away from the event happy, then we were successful because the odds of them participating with us again increases exponentially. Short term success leads to long term success. Long term success for soccer tournaments will be attracting more teams and families to the Klamath Basin. Soccer tournaments grow via word of mouth from soccer families and coaches. If they have a rewarding experience, they are more likely to tell other soccer communities about the success of our tournament.

Please explain how you plan to measure the success of your project in both the short term and the long term

Impact(250 words or less)

Our project addresses the need for tourism in the Klamath Basin and would utilize the beautiful soccer fields that are so well-known across the soccer community. Basin United would spend directly on marketing, while soccer families would spend directly on hotels and restaurants. Soccer tournaments would bring people in from outside Klamath County to spend money in the local economy. The Rogue Valley Soccer Tournament held each Memorial Day guarantees a four-game minimum for teams running from Saturday through to the championship rounds on Monday. This guarantees multiple night stays by thousands of participants from Oregon, California, and Nevada. With an incredible facility and an unbeatable summer climate, we could plan successful tournaments for soccer enthusiasts that would only continue to grow.
